### Objectives and investment policy

The Fund aims to provide a combination of medium to long term capital growth with income by investing mainly in shares of UK companies believed to offer good value or income prospects.

The Fund will also have some other investments in:

- index-linked and other bonds issued by governments or other organisations
- other investment funds

The Fund may use derivatives for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital.

Accumulation Units: Any income the Fund generates will be reinvested.

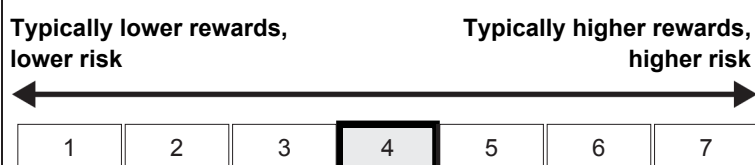
Income Units: Any income the Fund generates will be paid out to you.

### Risk and reward profile

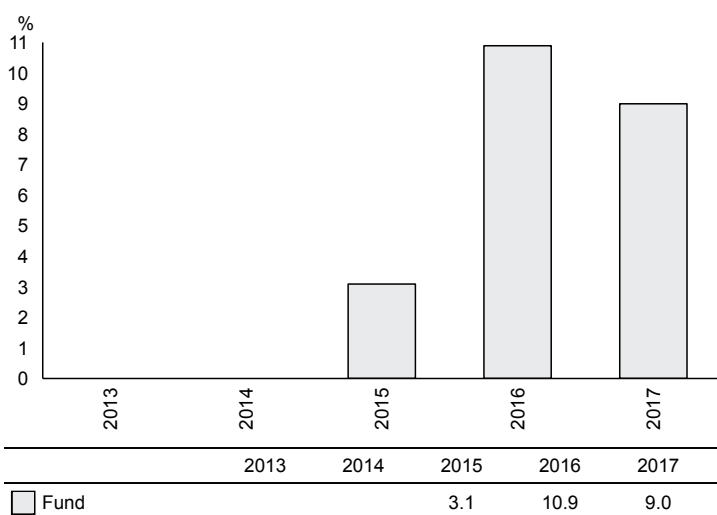
